you do not have a digital camera. The image should be a quality head shot,
similar to a passport photo. Use an uncluttered, plain, light-colored
background. No hats, caps or glasses. This will be the image that will appear
on your card for the next 5 years. It's okay to smile!
□ Send the digital photo to sos@therepublicoftexas1836.com.
☐ There is a charge of \$40.00 for the ID card to cover the costs incurred. If
sending a check or money order , make payable to: SOS Mary Reichardt.
☐ The ID card is valid for 5 years.
☐ If your card is lost or stolen or needs replacement during that time there is a cost of \$25.00 for a replacement card.
☐ If you come to one of these meetings you may also pay for your ID card with one and 1/2 oz of silver instead of \$40.00. I wouldn't recommend mailing silver but it has been done and you can. We also accept federal reserve notes.
 Also, an AFFIDAVIT OF FACTS AS A TEXIAN form is also required which can be found under this same tab.
